Customer Number (assigned w/ emp kit)		<ul style="list-style-type: none"> MT constant-speed propellers are manufactured by MT Propeller Entwicklung GmbH of Alting, Germany. They are used on many certified and experimental airplanes around the world. Pitch change is accomplished by either an electric or a hydraulic system. The hydraulic system is preferred because the pitch change is about 6 times faster. However, if your engine is not compatible with a hydraulic system, the electric gives you an alternative. Electric props are NOT recommended for aerobatics. Both two-blade and three-blade models are available. Van's does not maintain a stock of propellers. All MT propellers work with governors sold by Van's. A 25% non-refundable deposit is required with order. Payment in U.S. funds: check, money order, or Visa, Mastercard, Discover. Propellers include a Kevlar spinner assembly. Blades are white with red tips. Price includes shipping from Germany to the nearest assembly center only (see reverse). Customer is responsible for choosing and contacting the appropriate assembly center as well as assembly charges and shipping charges between the assembly center and final destination. Prices subject to change without notice. Customer instigated delays may result in price increase. Van's Aircraft, Inc. has not had the opportunity to test all MT models. It is the responsibility of the customer to determine the proper propeller application.
