## Registering and Licensing Your RV

The EAA has excellent tutorials including links to most of the forms you will need at:

They also offer an Amateur Built Certification Kit for \$12.99 (EAA member's price) that contains everything you'll need to get an 'N' number, register and license your RV and apply for a maintenance certificate.

Most FAA forms can also be accessed on-line by typing "FAA Form (*form number*)" into any of the various internet search engines. For example: FAA Form 8050-1 Aircraft Registration Application is available as a fill-able PDF file online at:

2. Van's Aircraft, as the kit manufacturer, will supply some of the necessary paperwork that you'll need to submit to the FAA, depending upon which RV model you've built.

For all RVs that will be licensed as Experimental Amateur Built (EAB) (this does not include RV-12 or RV-12iS aircraft being licensed as Experimental Light Sport Aircraft), Van's will supply FAA form 8050-2 Aircraft Bill of Sale.

For RV-12s that will be licensed as Experimental Light Sport Aircraft (ELSA), Van's will supply:

8050-1 Registration Application  
8050-2 Bill of Sale  
8050-88A Affidavit of Ownership  
8130-6 Application for Airworthiness Certificate  
8130-15 Statement of Compliance

### IMPORTANT NOTES:

1. On the next page you will find a Documentation Request Form. In order to receive the documents listed above, please fill out this form and send it to Van's Aircraft. Note: the RV-12 Documentation Kit contains all the RV-12 E-LSA forms listed above plus various RV-12 Manuals and Placards. Van's Aircraft cannot issue an RV-12 Documentation Kit without this request form. For E-LSA RV-12 requests, you must also have purchased a complete RV-12 Kit from Van's Aircraft and made no deletions from or additions to the kit.

2. No forms will be issued by Van's Aircraft for any model unless the current owner of the kit has supplied a completed and signed Waiver and Release of Liability Agreement to Van's Aircraft.
