NOTE: RV-12iS builders using the GMC 507 must use the WH-00134-1 or WH-00136-1 common harness. RV-12iS builders wishing to use the older GMC 305 or GMC 307 must use the WH-00134 (not WH-00134-1) or WH-00136 (not WH-00136-1) common harness of any revision.
