Synopsis:

An option for a premium wheel and brake system is now available for the RV-12 and RV-12iS. This brake system offers equivalent or better braking performance to the stock brake system. The premium system's main advantage is a significantly longer projected life of the brake components. Details about this option are now included in the RV-12iS KAI, the applicable sections of which are referred to below. Owners of existing original RV-12 aircraft should refer to the RV-12iS sections referenced below (available from the RV-12iS Service Information section of the Van's Aircraft website) when making this change. Existing aircraft owners may leverage this Service Letter for compliance should they wish to replace the original brake system with this new system.

Materials Required:

The following materials are required to complete the steps necessary to achieve compliance with this Service Letter 00030.

For aircraft without wheel pants:

Purchase Part no. 12 GROVE NO WHEELPANTS

For aircraft with wheel pants:

Purchase Part no. 12 GROVE FOR WHL PANTS

Method of Compliance:

Step 1: Referring to RV-12iS Section KAI 36iS/U, remove the wheel pants, if applicable.

<u>Step 2:</u> Referring to RV-12iS KAI Section 35iS/U, remove the tire and wheel, brake caliper and brake disc. Note the orientation of any shims between the axle and the gear leg.

<u>Step 3:</u> Referring to RV-12iS KAI Section 35GiS/U, install the Grove wheel and brake system. Note that an aircraft equipped with wheel pants will require a new axle, which is included in the wheel/brake packages listed above.

<u>Step 4:</u> Make a logbook entry indicating compliance with service document per the requirements of the controlling authority/agency.

Place a copy of this notification in the back of the maintenance manual for your aircraft. Note the addition of this notification to the bottom of the Maintenance Manual table of contents.
